

Power Supply

供電系統

The 110/22KV power station for Industrial Park and The Residental is ready for instant use. Capacity for the First phase is $63\,\text{MVA}$ and expandable to $63\,\text{+}40\,\text{MVA}$.

- · Power supply: From the national grid.
- Electricity price (regulated by the state).

Water Supply


